WHAT IS FEDERAL IMPACT AID?

Federal Impact Aid is designed to lessen the impact of federal activity on the budgets of school districts when parents are on active duty or live or work on certain federal properties.

This year the Madison County School System piloted an electronic survey via the PowerSchool Parent Portal. Unfortunately, not all parents have activated their PS Parent Portal accounts, which resulted in responses being much lower than our normal numbers.
